# LIABILITY WAIVER

By signing, I acknowledge my understanding that my participation in the 2017 Huntington Reeds Lake Run and/or any pre- or post-Event activities (collectively, the "Event") involves rigorous physical activity and that it potentially may be hazardous. I attest and verify that I am physically fit and have sufficiently trained for the Event and that, if appropriate, my physical fitness to participate in the Event has been verified by a licensed medical doctor. I expressly assume all known and unknown risks associated with the Event, including but not limited to: loss of or damage to my property; injury (including death); accidents; the effects of weather; terrain conditions that may vary widely, and that may include uneven and/or slippery surfaces, unpredictable spectators/participants, and natural and manmade obstacles (including without limitation, vehicles, security barriers, signs, cables, mats, and debris on the course); and the possibility that the Event may be postponed, ended early or cancelled altogether by Event or government officials.

I acknowledge that pet dogs may be present at, and may participate in, the Dog Run portion, and other portions, of the Event. I expressly assume all known and unknown risks associated with injury to person or property that may result from the presence and participation of pet dogs at the Event. I attest and verify that, to the best of my knowledge, any dog that I bring to participate in the Event does not have a known history of aggressiveness, nor has any such dog bitten or attacked any person. I further attest and verify that any such dog(s) that I bring to participate in the Event have had appropriate vaccinations as required by law. I hereby represent and warrant that I will keep any dog that I bring to the Event under my supervision and control at all times and will keep such dog restrained by leash at all times.

Further, I hereby acknowledge that in bringing my dog(s) to participate in the Event I understand that I am doing so at my sole risk. Any cost and expense and any harm that may come to the dog(s) shall be my sole responsibility; and in attending the Event with my dog(s), should any injury occur to any person, other animal, or property as a result of the behavior of my dog(s), whether expected or unexpected, regardless of the stimulus for the behavior (pets spontaneous conduct, conduct of another animal, conduct of any person or thing, or any combination therein) I will be solely liable and held responsible for any injury, or property damage that results from the participation of my dog(s) in the Event. Failure to sign the liability waiver will result in disqualification from the Event. The City reserves the right to refuse entry, for any animal if the animal's health or safety may be of concern. Participants are required to clean up all animal debris immediately after occurrence.

In consideration of my participation in the Event, I, for myself, my heirs, executors, administrators, personal representatives, successors and assigns (a)waive and release any and all rights, claims and causes of action I have or may have against any Released Party (as defined below)that may arise as a result of my participation in the Event; and (b)agree to indemnify, defend and hold harmless all Released Parties from and against any and all injuries, losses, causes of action, liabilities, damages, expenses (including attorneys' fees and court costs)or claims (collectively, "Claims")that might arise directly or indirectly from my participation in the Event and/or the condition of the raceway, property, facilities or equipment used for the Event, and/or injury caused by a domestic dog at the Event, regardless of when such Claim may arise, including without limitation Claims relating to (i) the negligence of a Released Party, (ii) any theft, loss, disappearance of or damage to property, and (iii) bodily injury (including death), in each case unless such Claim is caused solely by the gross negligence or willful misconduct of one or more Released Party. For these purposes, a "Released Party", is any one or more of the following: all Event officials and organizers; all governmental agencies representing the territory in which the Event will be held and from which resources (such as, without limitation, fire, police and ambulance personnel) are provided; all sponsors, agents, vendors, and contractors of or for the Event; USATF officials; emergency (for example, fire and police) and all medical service providers; and the officers, directors, employees, representatives, successors and assigns of each of the foregoing. I acknowledge that sponsors and their affiliates have no control over the operation of the Event or the acts or omissions of Event officials and organizers.

I further grant full permission to any and all of the foregoing to store, use and/or reproduce my image or likeness by any audio and/or visual recording technique (including electronic/digital) now in existence or hereafter invented, for any legitimate purpose, including commercial sales and marketing purposes. I understand and agree that information about me that is collected by the Event officials, including without limitation information on this form and my Event results may be disclosed to third parties for any legitimate purpose, including commercial sales and marketing purposes, and that it may be subject to re-disclosure by the recipient(s).

I acknowledge and agree to abide by any Official Rules for the Event that may be posted at the Event or on the Event's website or otherwise communicated to me verbally or in writing at the Event by Event officials. I hereby represent and warrant that I am 18 years of age or older or, if applicable, that I am the parent or legal guardian of the child under the age of 18 years old who I am registering for the Event and that I have the full power and authority to agree to these terms on behalf of such child, and to bind him/her to these terms.
